IN CONSIDERATION of being permitted to participate in the referenced "Athletic Activities", defined as the youth sports programs conducted under the auspices of the Greek Orthodox Archdiocese of North America, which include but are not limited to the Greek Orthodox Basketball League & Soccer League programs (hereinafter referred to as the "Sports League") and the St. Nicholas Greek Orthodox Shrine Church of Flushing Junior, J.O.Y. & G.O.Y.A. Basketball Program & Soccer Program (hereinafter referred to as the "St. Nicholas Sports Program"), the above-named registrant Player (hereinafter referred to as the "Player") and I, the undersigned parent/guardian, agree to the terms of this waiver form and agree to abide by the General Rules of the Sports League and the rules set forth in the administration of the St. Nicholas Sports Program. As parent/guardian of

the Player, I am familiar with his/her wishes to participate in sports. I am aware that with participation in Athletic Activities comes the risk of injury to the Player and that this may increase in contact sports like basketball and soccer. I understand the possible risks inherent in participating in these Athletic Activities. In addition, I am aware that participation in the Sports League and St. Nicholas Sports Program will involve travel to and from an activity, practice, game or other related event and I acknowledge the potential risk of injury traveling to and from such activity, practice, game or other related event. The Player and I acknowledge and accept the risks inherent in participating in such Athletic Activities and the travel involved with respect to the Sports League and St. Nicholas Sports Program. With this knowledge in mind, I grant permission to the Player to participate and travel. The Player and I assume all the risks and hazards incidental and inherent in the conduct of such Athletic Activities and hereby release, waive, discharge, and covenant not to sue, St. Nicholas Greek Orthodox Shrine Church of Flushing, NY, Greek Orthodox Archdiocese of America, Greek Orthodox Sports League and those associated with these entities including but not limited to the other League communities, teams, coaches and players and the Clergy, Officers, Council Members, Directors, Coaches, Members, Consultants, Supervisors, Managers, Agents and Employees (hereinafter referred to as the "Releasees") from all liability to the Player his personal representatives, assigns, heirs and next of kin for any and all loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the Player, whether caused by the negligence of the Releasees or otherwise while the Player is in, upon, or about the premises or any facilities or using the equipment therein participating in any program affiliated with the Sports League and St. Nicholas Sports Program. The Player and I hereby agree to indemnify and save and hold harmless the Releasees and each of them from any loss, liability, damage, payment of any settlements or the defense of any suits or cost they may incur due to suits including but not limited to attorney fees while the presence of the Player is in, upon or about the premises or any facilities or use of equipment or is therein participating in any program affiliated with the Sports League and St. Nicholas Sports Program. The Player and I hereby assume full responsibility for and risk to bodily injury, death or property damage due to the negligence of the Releasees or otherwise while the Player is in, upon, or about the premises or any facilities or using the equipment therein participating in any program affiliated with the Sports League and St. Nicholas Sports Program. In addition, the Player and I hold harmless and release from any and all liabilities, any person(s) transporting to or from any Sports League and St. Nicholas Sports Program related activity scheduled or arranged by the Releasees. In the event that I cannot obtain a physicians note stating that the Player can participate in the Sports League and St. Nicholas Sports Program, I represent that the Player has been recently examined by a physician, is in good health and has no physical or mental disabilities that would prevent him from fully participating in the Sports League and St. Nicholas Sports Program. I consent to any emergency medical treatment of my child, in the event I cannot be reached within a reasonable time. The Player and I hereby consent to the use of photographic images of the Player solely for the purposes of promoting the Sports League and St. Nicholas Sports Program. The Player and I further expressly agree that the foregoing Release, Waiver and Indemnity Agreement is intended to be as broad and inclusive as is permitted by the laws of the State of New York and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. I herewith acknowledge understanding the Consent Form above and agree to its terms.
